if the said Nimrod Underwood his heirs Executors, or administrators
shall and do will and truly pay, or cause to be paid unto the said per-
-son a bove named his securities or their certain attorney, Executor, ad-
-ministrators or assigns the full and just sum a bove mentioned of
thirteen hundred dollars, indemnify and save them harmless against all
future payments, losses or liabilities according to the true intent &
meaning of this deed, then this deed of bargain and sale, and all and
every clause, article and thing therein contained shall cease, deter-
-min, and be utterly void and of none effect; any thing herein con-
-tained to the contrary thereof in any wise notwithstanding
And it is hereby declared, by and between the parties, and the said
Nimrod Underwood, for him self & his Executors, administrators, and
assigns doth covenant, promise, and agree, to and with the securities
person a bove named named & their Executors administrators, and
assigns, by these presents, that if default shall happen to be made of
or in payment of the said sum of money & in the indemnity as afores
-aid, according to the true intent and meaning of the deed that then
and in such case it shall and may be lawful to and for the said
securities & their Executors administrators, attorneys, or agents from
time to time and at all times hereafter peaceably and quietly to enter in
or all the messuages, lands or tenements of the said Nimrod Underwood
