 granted, bargained, sold & released & by these presents do grant bargain, sell and release
 unto the said Hartwell Lister all that plantation or tract of land excepting half an acre
 around the burying ground late the residence of the said Archibald Lister dec'd,
 containing 50 Acres, more or less situate in Greenville District in the State aforesaid on
 both sides of Gilders Creek, beginning at a red oak 3x near the Greenville Road &
 runs on Felix Gruns line N 16 W 9. 50. to Stake S. 32. E 9 Chains to a white oak 3x 3x on the
 North bank of Gilders Creek then up said Creek to Dr Benjamin Kilgore's line
 then with his line N 16 W 13. 00 to the Cool branch, then up the said branch to its
 head then with Dr. B. Kilgore's S 19. E. 3. 00 to a small Post-oak 3x 3x thence S. 70 W 40. 00 to a
 Post-oak 3x then with Paschal Rutledge's line S 45. W 21. 00 to a Pine 3x then W 1. 25. 50 to a Post-
 oak 3x on the old Indian Boundary line then on said line due North 55 Chs to a
 Red oak bush 3x then with Samuel B. Hill's line S 80. E. 9 Chs to a Post oak 3x 3x then N 10
 E. 50 to a Stake on the Greenville Road, then down said Road to the beginning being
 part of a tract of land granted to Joak Stitchel 17 & part of a grant to
 William Stitcheson. Together with all and singular the rights, members, hereditamen-
 ts, and appurtenances to the said premises, belonging or in any wise incident or ap-
 pertaining to have and to hold all and singular the premises, before mention-
 ed unto the said Hartwell Lister his heirs and assigns for ever and we do hereby
 bind ourselves, as Executors of the said Archibald Lister dec'd to warrant
 and for ever defend all and singular the said premises unto the said Hartwell Lister
 his heirs and assigns against ourselves and the heirs of the said Archibald
 Lister dec'd and against every person whomsoever lawfully claiming or to claim

 2. 57 to a P. O 3x then S. 34. 22. to a P. O 3x then N. 69. E by a dividing line between Woodruff
 & Shackston to the Beginning Together with all and singular the rights, members, he-
 reditaments & appurtenances to the said premises, belonging or in any wise incident or
 appertaining to have and to hold all and singular the premises, before mention-
 ed unto the said Hartwell Lister his heirs and assigns for ever. And I do hereby bind
 myself, my heirs, Executors & administrators to warrant and for ever defend
 all and singular the said premises unto the said Hartwell Lister his
