Beginning on a pine 3x thence N. 34. E. 54. ch. to a stake 3x thence N. 44. W. 75. ch. thence 3x thence S. 17. W. 96. 30 ch. Stone 3x and Legans land thence S. 54. E. 45. 50. Post-Oak Line S. 51. E. 23. 1/2 to the Beginning Pine corner containing by Estimation five hundred and seventy four Acres be the same more or less which land was originally granted to James Jett by his Excellency William Moultrie, which land was conveyed from sd Jett to George Harrison & from him to Thomas Edwards Senr and from him to William E. Wickliff and now from William E. Wickliff to J. H. Goodlett situate on the waters of the Saluda River, and the Long Branch of Rudy River Together with all and singular the Rights members, hereditaments and Appurtenances to the said premises belonging or in any wise incident or appertaining to have and to hold all and singular the aforesaid premises unto the said J.
