 in hand paid by Thomas Edwards, Jr. of the State and District afo-
 resaid the receipt whereof is hereby acknowledged have granted han-
 gained and delivered and by these presents do grant bargain sell, Release
 convey and confirm unto the said Thomas Edwards, Jr. his heirs and
 assigns all that plantation, tract, or parcel of land wherein I now
 live containing five hundred acres be the same more or less situate
 in Greenville district aforesaid on both sides of the Panthers Fork of
 Little Creek waters of Saluda River including the whole of a tract
 of two hundred and forty seven acres granted to Esther Thomas by a
 grant bearing date the fifteenth of October one thousand seven
 hundred and eighty five the balance being a part of a tract of
 land of fifteen hundred and twenty acres granted to George Salm
 on by grant bearing date the second of April one thousand seven
 hundred and Eighty Seven the the whole of the land hereby intituted
 to be conveyed runs as follows that is to say begining on a white
 Oak on the south side of the Panthers fork thence South Eighty
 two degrees East thirty six chains and fifty links to a Stake thence North
 eighty degrees East fifty chains to a red oak thence North Eighty two
 degrees west fifty one chains to a Stake and painted thence North Sixty
 five degrees West fourteen chains to a small red oak Rodins line thence
 South Sixty two degrees West with Rodins line forty nine chains to
 a persimmon on the North side of the Panthers Fork, thence down
 the meanders of said fork to the mouth of a small branch that
 heads near the fork of the Adenville and Rutland Roads thence up
 the said branch to its source thence up the hollows of the same a straight
 line to a red Oak near the fork of said Roads, thence North forty
 degrees East to a Post Oak thence North ten degrees East forty three chains
 and fifty links to the begining containing in the whole five hundred
 acres more or less as aforesaid together with all and singular the Rights
 numbers, boundaries and appurtenances to the said premises belonging
 or in any wise incident or appertaining to have and to hold all and
