all and singular the premises before mentioned unto the said John
Masteller his heirs and assigns for ever and I do hereby bind myself my
heirs Ex'tors and administrators to warrant & for ever defend all
and singular the said premises unto the said John Masteller his
heirs and assigns against myself and my heirs and against every per-
son or persons whosoever lawfully claiming or to claim the
