and fifteen dollars to me paid by my son Mason H. Nabours have granted bargained
sold and released and by these presents do grant, bargain sell and release unto the said Ma-
son H. Nabours a certain tract or parcel of land containing two hundred and two acres
more or less situate in the state and ^{chiefly} in the district aforesaid on Ridge creek a branch
of Saluda River beginning on a rock & thence N 42° E. 35.00 to a mother rock & binding
on Master Nabours land thence N 47° E. 6.50 to a stake & thence S 88° E 17.00 to a
white oak 3x thence \$1.50 to a poplar 3x on line creek thence up the meanders
of said creek to Allen F. Nabours corner thence N 36° W. 35.00 to a stake 3x binding
on Allen F. Nabours land thence S 52° W 53.50 to the beginning, binding on said
Samuel Nabours together with all and singular the rights, members hereditaments and
appurtenances to the said premises belonging or in any wise incident or appertaining
To Have and To Hold all and singular the premises before mentioned unto the
said Mason H. Nabours his heirs and assigns forever. And I do hereby bind myself
and my heirs my executors and administrators to warrant and forever defend
all and singular the premises before mentioned unto the said Mason H. Nabours
his heirs and assigns against me and my heirs and also against
every other person or persons whosoever lawfully claiming the same
