 dollars & fifty five cents to me paid by Jeremiah Cleveland of Greenville Dis-
 trict in the state aforesaid have Granted, bargained, sold and released, and
 by these presents do grant, bargain, sell and release, unto the said Jeremiah Cleveland
 Afield or tract of land where an I now live it being part of land originally
 granted to James West by his Excellency William Moultrie Governor and Com-
 mander in chief of said State on the 6th day of November one thousand
 seven hundred and eighty six and deeded by said James West to
 Hephzibah Cockrum Conveyed from Hephzibah Cockrum to Daniel
 Cockrum by deed of gift lying on the south side of Rudy Fork waters
 of Rudy River Beginning on a stake of the original line in a marsh
 corner of a piece of land deeded to John Gordon running from thence
 down the Marsh to where it intersects a branch that runs from
 Isaac Roberts Spring thence down the branch to the Creek thence
 down the Creek untill a certain white oak will be in line with the
 next corner a persimmon at the back of said Daniel Cockrum Smoke
 House from thence to the beginning together with all and singular
 the rights, members, hereditaments and appurtenances to the said prem-
 ises belonging or in any wise incident or appertaining to House and
 to Hold all and singular the premises before mentioned, unto the
 said Jeremiah Cleveland his heirs and assigns for ever and I do
 hereby bind myself my heirs, Executors and administrators to warrant
 and for ever defend all and singular the said premises, unto the
 said Jeremiah Cleveland his heirs and assigns, against myself
 and my heirs, or any other persons lawfully claiming or to
 claim the same, or any part thereof. Witness my hand and
 Seal this Eleventh day of March in the year of our Lord one thou-
 sand eight hundred and twenty eight and in the fifty second
 year of the independence of the United States of America —
