



 my heirs, Executors and administrators to warrant and forever
 defend all and singular the said premises unto the said John W.
 Lewis & John S. Rowland their heirs and assigns against me & my
 heirs and against every other person whomsoever lawfully claiming
 or to claim the same or any part thereof. Witness my hand &
 seal this seventh day of July in the year of our Lord one thousand

 said Elijah Smith all that tract or parcel of Land contain-
