Beginning at a Spanish oak and Running thence N<sup>o</sup> 64 E 13 Chains to a  
white thence S<sup>o</sup> 17 Chains to a chestnut thence N<sup>o</sup> 74 E 12 Chains 50 links to  
a large Chestnut oak thence S<sup>o</sup> 5 W to an aged corner a turkey oak  
Saklin thence to the mouth of the Rocky Spur Branch thence up the bank  
to a pine thence S<sup>o</sup> 35 west to a stake thence N<sup>o</sup> 23 Chains to the Beginning  
Containing by Estimation fifty acres be the same more or less the same being  
the upper End of a tract containing one hundred and Sixty six acres granted  
from the State bearing date 3<sup>rd</sup> September 1804 Together with all and  
Singular the Rights members Hereditaments appurtenances thereunto
