 Greenville District } day of February in the year of our  
 Lord one thousand eight hundred and thirty Two Between John Watson  
 ordinary of the district aforesaid and John H Rosamond of Anderson  
 district in the State aforesaid Whereas a summons of partition to  
 Divide or Sell a certain tract of Land hereinafter described of the Estate  
 of John Gordain Deceased Issued from the Court of ordinary of said  
 district and upon the return thereof the Judge of said Court did  
 Determine that the Said Land could not be Divided without Injury  
 to the Interest of the parties and did order the Same to be Sold by  
 the Sherriff of the district aforesaid on a credit of Two years whereupon  
 the Sherriff aforesaid did advertise the Said Land for Sale on the  
 first monday in December A.D. 1831 and whereas the Sherriff aforesaid  
 did on the Said day Expose to Sale at public outcry on the Credit  
 aforesaid the Said Land When the Said John H Rosamond was the  
 Last and Highest bidder to Whome the Said Land was Struck off for  
 the Sum of Six hundred and fifty one dollars

Now this Indenture Witnesseth that in Consideration of Six hundred  
 and fifty one dollars to me paid I have Granted bargained Sold  
 and Released and by these presents do Grant Bargain Sell and Release  
 to the Said John Rosamond his heirs and assigns forever all that tract  
 of Land situate in said district on the Waters of Salludia River Con-  
 taining five hundred acres be the Same more or Less it being part of  
 a tract of Land Granted to Harris Mullen but Surveyed for John  
 Huger and was Conveyed to the said John Gordain Deceased by Waddy  
 Thompson Esq and hath such bounds marks & as follows Viz.

Beginning on a red oak 3x Running thence N 80 to a post oak 3x thence  
 East about 35 or 40 to the Road thence along Crawford's line to the old  
 original line thence along the original line to the Beginning with  
 the appertinances thereunto belonging and all the Estate Right  
 title Interest claim or demand which the Said John Gordain Deceased  
 at the time of his Death had or to the Same To have and to hold the  
 Said tract of Land Together with all and singular the premises Im-  
 provements and appertinances to the Said John H Rosamond his  
 heirs and assigns forever in Witness Whereof I the Said John Watson  
 ordinary aforesaid have hereunto set my hand and Seal the day  
 and year above mentioned
