John Roberson to Joseph P Labruce the nineteenth day of October
A.D. 1824 as will appear on a reference to said conveyance and
from the Executor and Executrix of the said Joseph P Labruce now
Deceased to said John Watson Given under my hand and seal this
Twelfth day of March A.D. 1832



I know all men by these presents that I Isaac Morgan of Greenville district
and State aforesaid for and in consideration of three hundred dollars to
me in hand paid by Elizabeth Morgan of said State and district have
Bargained Sold and released and do by these presents sell Bargain and
Release unto the said Elizabeth Morgan all my right title and interest
to her the lands Belonging to the Estate of Ispe Morgan deceased of said
district and do by these presents warrant and forever defend the rights
and titles to all my undivided Interest in said lands unto the said
Elizabeth Morgan her heirs Executors & administrators against myself
my heirs Executors and administrators and against every other person
or persons lawfully claiming the same or any part thereof witness my
hand and seal this 12th day of August A.D. 1829

The condition of the above deed is such that if the above named
Isaac Morgan doth pay or cause to be paid his note of hand bearing
Even date with these presents for the sum of Ninety seven dollars Thirty
Six Cents payable to the said Elizabeth Morgan agreeable to the face
of said note then the above deed to be null and void and of no
Effect otherwise to remain in full force and virtue both in Law and
Equity this the day and date above written
