 the seizure by me made by Virtue of the Said writ of Fieri facias before
 mentioned have been Exposed to Sale at public Vendue and purchased
 by Jeremiah Cleveland of the district aforesaid for the Sum of one
 hundred and thirty dollars being the highest Sum that was bidden
 therefor now know ye that I William Blasingame Sheriff aforesaid
 by Virtue of the Said writ of Fieri facias to me directed and delivered
 as aforesaid and by Virtue of the Statute in such cases made and provided
 and for and in consideration of the Said Sum of one hundred and thirty
 dollars to me in hand paid or Secured to be paid by the Said Jeremiah
 Cleveland the Receipt and payment Whereof I do hereby acknowledge have

 Sell unto the Said Jeremiah Cleveland his heirs and assigns forever the Said

 Right title and Interest which the Said Daniel Cochrum of right had
 of in and to the Same to have and to hold the Said piece parcell and tract
