Goodlett deceased to levy the sum of twelve hundred and eighty four dollars Damages and costs I have seized and taken of the lands and tenements of the Said John H. Goodlett all that certain piece parcel and tract of land containing Sixty eight acres more or less situate and being in the district of Greenville lying and being on the waters of Reedy River begining on a Spanish oak on the main
