of two hundred dollars to me in hand paid William Twitty of Rutherford County
and State of North Carolina have granted bargained sold and conveyed
unto the said William Twitty a certain tract or parcel of land lying in Greenville
district and State aforesaid containing Sixty two acres beginning on the North
Side of Bevordam Creek a Branch of Middle Tyger River it being the Northern
of a survey granted to Augustin Derrick January 15th 1787 Beginning at a white
oak thence North fifteen chains fifty links to a hickory thence N 82 E 23 chains
to a red oak thence So 16 chains to a stake on the bank of creek thence up the
