I know all men by these presents that I Calvin Ellis of Greenville district in the State aforesaid for and Inconsideration of the Sum of twelve hundred dollars to me in hand paid by Vardry Mc Bee of North Carolina the receipt and payment of which is hereby acknowledged have Bargained Sold and quit claim all my Equitable Interest in a certain tract of Land lying on Both Sides of Eedy River whereon I now live Together With all the Mills Building and Machinery of Every description hereunto belonging being the Same place whereon Samuel Thompson lately dwelt containing two hundred and ninety five acres of Land 295 and which Land has already been Sold & conveyed by the Said Samuel Thompson to the Said Vardry Mc Bee and in Whom the titles to Said Land was Entirely in the Said Samuel and now in the Said Vardry Mc Bee by the conveyance from the Said Samuel Thompson to the Said Vardry Mc Bee the Legal titles of the Said Land never was in me having had a title Bond from Samuel Thompson that never was complied With but having paid Samuel Thompson something it was considered that I had an Equitable Interest in part of the Land and which Said Interest is hereby conveyed and from then to the Said Vardry Mc Bee his heirs and assigns forever from me and my heirs and from all and Every other person or persons whatsoever Lawfully claiming or to claim the Same In Witness Whereof I have hereunto set my hand and Seal this 11th day of October 1832
