deration of the Sum of one hundred dollars to me in hand paid by  
John Crawford of the State and district aforesaid have Granted Bargain-  
ined Sold and Released and by these presents do Grant Bargain  
Sell and release unto the Said John Crawford a certain Parcel or tract  
of Land containing about two hundred acres the Same be more or  
less Situate in Greenville district and State aforesaid lying on the  
South Side of Fortinberys Beverdam it being part of a Tract of Land  
containing Eight hundred and Seventy two acres Granted to me the  
Said Boswell the line of the Said two hundred acres runs as follows, Begi-  
ning on a hickery Running Southward along Standfords line to a  
Black oak thence Eastward along Suttins line till Barneses Branch  
thence down the Said Branch till Swifts line thence along Swifts line till  
the Begining Together With all and Singular the rights members Her-  
edements and appurtenances to the Said Land Belonging or  
any wise appertaining to have and to hold all and Singular the  
premises afoe mentioned unto the Said John Crawford his heirs and  
assigns forever and I do hereby bind myself my heirs Executors and  
Administrators to Warrant and forever defend all and Singular the  
premises unto the Said John Crawford his heirs and assigns against  
myself and my heirs and against any person Whomsoever lawfully  
claiming the Same or any part thereof as Witness my hand and  
Seal this 23<sup>d</sup> day of July in the year Eighteen hundred and one  
and the 26<sup>th</sup> year of americans Independence
