 Whereas I Isaiah Pickett did Receive under the Will of my Father Micajah Pickett Deceased in the month of January one thousand eight hundred and Twenty three the following property viz four Negroes namely Ned Daphener Lucy and her child Bill appraised at fourteen hundred and twenty five dollars also one thousand dollars from Sep the Pickett under Said Will amounting in the whole to twenty four hundred and twenty five dollars which Sum the Commissioner in Equity for Greenville district or Sheriff or the Trustees or the master and clerk in north Carolina or Sheriff or the Trustee of the Bond & covenant of my Father Micajah Pickett Senr to his Wife Kesannah Pickett of the tenth of January 1805 Shall and is hereby directed to credit the Same on my portion of Said Bond and they are hereby ordered and directed forthwith to pay over to James Pickett all the Ballance which is or will be due me on Said Bond and its decree and this Shall be my full authority and receipt for the Same as Witness hereunto I doth set my hand and Seal this 9<sup>th</sup> day of September A.D. 1828
