State of South Greenville district Know all men by these presents that Strother D Shumate of the State and district in consideration of two hundred dollars in hand paid by Jefe French of the State and district aforesaid have granted bargained and sold and release unto Jefe French all that plantation or tract of Land containing by Estimation one hundred acres be the Same more or less Situate in the district aforesaid Lying on Mountain creek and the beaver dam creek and Waters of Saludia River Beginning on a line 3x in fork of the Beverdam and Mounting creek Running thence North Nearly 30 West up the Meanders of Mounting at 40 links distance from Low Water Mark to a swamp oak 3x the distance being about fifty chains thence N. 76 E 46 chains on Richards Mannings and Charles Postices line to a maple 3x on the Beverdam creek thence down the Meanders of Said creek to the Beginning Together with all and Singular the rights members Heredeterments and appurtenances to the Said premises Belonging or any wise Incident or appertaining to have and to hold all and Singular the Premises before mentioned unto the Said Jefe French his heirs and assigns forever and I do hereby bind myself my heirs Executors and Administrators to warrant and forever defend all and Singular the Said premises unto the Said Jefe French his heirs or assigns against myself my heirs or assigns lawfully blaming the Same or any part thereof Witness my hand and Seal this twenty Sixth day of January in the year of our Lord one thousand Eight hundred and thirty three and in the fifty seventh year of the americans Independence of the united States signed Sealed and delivered in the presence of
