payment of the Said Sum above mentioned according to the true Intent and mean-
ing of the Said Contract and agreement or if the Said Robert M. Young shall
become liable so as to have any thing to pay or in any way become looser
by incurring the aforesaid Liability that then and in such case it shall
and may be lawfull to and for the Said Robert M. Young his Executors
Administrators, assigns attorneys or agents from time to time and at any
times hereafter peacefully & quietly to take said negro Slaves into his Custody
& Possession & the same to hold and detain to his own use and behoof (as his
own proper goods from henceforth & forever or the same to sell and dispose of at
his own Will and pleasure returning the overplus, if any should happen to be
after paying the Sum above mentioned and Indemnifying the Said Robert
M. Young as mentioned aforesaid Witness my hand and Seal this 27th
December in the year of our Lord one thousand eight hundred and
thirty two Signed Sealed & delivered
