 Paschal Rutledge of right had of in and to the same to have and to hold the said  
 piece parcel and tract of Land with its appurtenances unto the said Edmond  
 W. Garrison his heirs and assigns for ever as fully and absolutely as the said  
 William Blasingame might could or ought to Grant Bargain and Sell the  
 same by virtue of the Statute aforesaid and the said Writ of Fieri Facias  
 or otherwise In Witness whereof I the said William Blasingame have hereunto
