 acres more or less Situate in the district of Greenville on the Branches of Mush
 Creek Waters of Tyger River being part of a tract of Land conveyed by
 Archable Taylor to William P. Pool Jun^r and is bound as follows (Viz)
 Beginning on a post oak on the ridge on the South East Side of Mush Creek
 Samuel Boswells Corner thence South Sixty Eight and a half degrees West
 31 chains 50 links to a red oak thence S. 19. W. 12. 50 to a white oak thence
 S. 82. E. 21 to a stake thence N. 35. E. 4 to a post oak Stump thence due East
 5 chains to a stake by a small Branch thence down the Meander Said branch
 to a maple at the mouth of Said Branch thence N. 35 W to the Beginning
 containing Sixty Eight acres more or less as aforesaid Together with all
 and Singular the rights members Hereditaments and appurtenances
 to the premises belonging or in any wise Incident or appertaining to have and
 to hold all and Singular the premises above mentioned unto the Said Samuel
 Boswell his heirs and assigns forever and I do hereby bind myself my heirs
