W. 12 ch 10 links to a stake 111x thence S. 10. W. 52 ch. 40 links to a stake 111x thence N. 81 E. 13 ch to a stake 111x in fork of the creek thence N. 10. E. 50 ch. 50 links to State 111x on thence No 80. E. 69 ch to R. o. 111x dead thence due North 35. 50th to State 111x on thence due West 56. 50 to P. o. 111x on thence S. 10. W. 15. 50th to the Beginning corner to have and to hold all and singular the rights members & above mentioned unto the Said James A Harrison his heirs assigns administrators Executors &c but Whereas Swannah Harrison the mother of the Said Jas. A Harrison being allowed the Benefit of the plantation left her by John Harrison Deceased her former husband & the Said James A Harrison having Sold the Same; this is therefore to certify that the Said Swannah Harrison is to be Entitled to the Benefit of the Place that the one she is now disposed of is Bartered for, and also Entitled to all the priviledges as she was of the former Place during her life & at her death all her Interest in the above named deed shall fall in to the hands of the above named James A Harrison in the manner prescribed in the Will of John Harrison deceased then the Said James A Harrison to have and to hold the Same forever from me my heirs assigns &c and from all other persons lawfully claiming the Same or any part thereof In Witness Whereof I have hereunto set my hand & affixed my seal this 23^d day of September 1833 & of the Independence of these united States the fifty Seventh & fifty Eighth
