

Smith for Seven hundred and twenty one dollars being at that price the highest for the Same Now therefore this Indenture Witnesseth that the Said William Choise as Commissioner of the Said Court under and by virtue of the Said Decree and in consideration of the Sum of Seven hundred and twenty one dollars paid him by the Said George W. Smith the Receipt whereof is hereby acknowledged hath granted bargained sold and released and by these presents doth grant bargain sell and release unto the Said George W. Smith his heirs and assigns all that tract of land lying in Greenville district on Saluda River containing one hundred and forty four acres more or less beginning at a small white oak 3x on the bank of Saluda River running thence N 72 W 23 to a red oak 3x thence S 42 E 7.50 to a Stake 3x at the horse Shoe on Mountain creek thence down the Meanders of Saia creek to a white oak 3x not far above the mouth of a branch thence S 40 W 25 to a post oak 3x thence due West 14.40 to a white oak on Saluda and thence up the Meanders of the Said River to the beginning as the annexed plan Represents Together with all and singular the Herein determined Rights members and appertainances whatsoever to the Said tract of land belonging or in any wise appertaining and the Reversions and Remainders Issues and profits thereof and also all the Estate Right title Interest dower Possession Property Benefit claim and demand whatsoever both at Law and in Equity of the heirs and representatives of the Said John P French Deceased and of all the parties to this Suit and of all other persons right fully claiming or to claim the Same or any part thereof by from or under them or either of them to have and to hold the Said tract of land with its Herein determined privileges and appertinances unto the Said George W Smith his heirs and assigns to his and their only proper use Benefit and behoof for ever Witness whereof the Said William Choise as Commissioner of the Said Court under and by virtue of the Said decretal hath hereunto set his hand and the Seal of the Court on the day and year first above written
