South Carolina (Duplicate) Know all men by these presents that I Joseph H. Waring of St. Pauls parish State aforesaid for and in consideration of the Natural Love and affection which I have for my Daughter Cornelia m. Joor and to the Intent to make provision for the maintenance and the maintenance of any child or children she may have by her present or any future husband and for the sum of five dollars now paid to me by Jor Joor Waring and Tho W. Boone the receipt whereof I do hereby acknowledge and for Divers other good causes and valuable considerations me thereunto moving I the said Joseph H. Waring have given and granted and by these presents do give and grant unto them the said Jor Joor Waring and Tho W. Boone the following negroes To wit. Morris Nancy Peggy her child Harry Rose her child Henry Rynah her child Jacob Chance and Delia also two Horses a chair and Harness also the following articles of Furniture To wit; one dining Table one pair card Tables one Work Table one Hender one pair Dogs one Shovel and pair of Tongs one Carpet Bedstead and Bedding and Bedding Furniture coat of Waters a pair of Candelsticks carpenter Tools consisting of Broad axe Auger adze Planes Hatchet Hammer and Square pair of pitchforks one Socking & Lap Side Saddle Bridle and Sundry articles of Cookery and Glass Ware In Trust nevertheless that the said Jor Joor Waring and Tho W. Boone the Survivors of them and the Executors administrators and assigns of such Survivor do permit the said negroes Horses Chair furniture &c to remain in the possession of the said Cornelia m. Joor for and during her natural life and during that period to permit the said Cornelia to receive and enjoy the profits of the labour of the said negroes and their future Increase and the use of the said Horses Chair Harness and articles of furniture to be to her sole and separate use free from the Debts which now exist or may hereafter be contracted by her present or any future husband and in further Trust at the Death of the said Cornelia leaving a child or children then and in that case to permit the Guardian of said child or children to receive the Labour and profits of the said negroes and the Increase thereof to and for the maintenance and Education of such child or children until such period as the child or children may be of proper age and discretion to receive and manage their property then the said trustees the Survivor of them his Executors administrators and assigns to deliver the said negroes to such child or children free and discharged from and trust or condition whatsoever but in case the said Cornelia should depart this life leaving a husband living at her death but leaving no child or children of issue of any child or children then the said trustees the
