Greenville district 3 Blasingame of the Said district and State for
an Inconsideration of the sum of Eighteen hundred dollars to me
in hand paid the receipt whereof is hereby acknowledged have granted
Bargained Sold and released and by these presents do Grant Bargain sell
and release to Eliza H Simphkins of the Said State and district of Edg Pid
all that tract or Parcel of land lying on the road leading from Greenville
to Pendleton old C. & about three miles from the former Place Embracing
what is commonly called my old Place and houses containing as laid
of two hundred and forty two acres or there abouts Bounded on the North
ward by lands of J Cleveland Esqr on the East by lands of the Estates
of J Alston on the South by lands of D. Hoke and Mr. Townes and on
the West by lands of the Said J Blasingame and hath such marks
and bounds as are laid down on a plat surveyed by John Watson
which Said plat is hereunto annexed and hereby referred to as consti
tuting part of this Conveyance with the exception that the western line
of Said plat running from a R. 0k 3x3 on N 31 W to a pine corner
is then to be continued in a straight line until it strikes the back
line on J Cleveland's land according to a line dotted off with Ink
and cutting of about twelve and a half acres from the general
plat With this exception the Said plat is to constitute boundaries
together with all and Singular the Rights and appurtenances and
incidents belonging to the Said land or in any wise appertaining
to the same to have and to hold unto the Said Eliza H Simphkins
her heirs and assigns forever and I do hereby bind myself my heirs
