to a rock 37 Bounding on R Coxes land thence S. 83. W. 8.30 to a stake 37 thence  
N. 7. W. 18.50 to a rock 37 thence N. 88. E. 8.30 to a red oak 37 Bounding on  
Rebecca Stones land thence down the Meanders of a branch to its Confluence  
with Mountain Creek thence down the Meanders of said Creek within forty  
links of High Water Mark to the Beginning Together with all and sin-  
-gular the rights members Hereditaments and appurtenances to the said  
premises belonging or in any wise incident or appertaining to have and  
to hold all and singular the premises before mentioned unto the said  
Martin Stone his heirs and assigns forever and I do hereby bind myself
