 and Administrators and assigns a negroe Girl named Sarah about
 nine years old and her Increase to be Equally divided between them
 to have and to hold the Said negroe Girl Sarah unto the Said heirs
 forever and the Said Susannah Roberts do bind myself and my heirs
 Executors and Administrators and assigns forever unto my Daughter
 Nancy Caroline Roberts and the other heirs and I do warrant and
 forever defend the Said Negro Girl unto the Said heirs of my body
 there Executors and Administrators and every other person Whomsoever
 against myself and my Executors and Administrators and I war-
 rant and forever defend In Testimony Whereof I have this day
 hereunto Set my hand and Seal this 4th day of October 1834

 aforesaid have Granted Bargained Sold and released and by these presents
 do bargain Sell and release unto the Said William Goodlett all that tract
 or parcel of land Situate on the Waters of North Saluda beginning on
 a Spanish Oak near the road thence to a black oak thence to a stake on
 the old road leading to Chalmers School House thence along the old
 road to the beginning corner on the Spanish Oak corner in the whole
 twenty acres be the same more or less Together with all and singular
 the Rights members Hereditaments and appurtenances to the Said
 premises belonging or in any wise Incident or appurtenant thereto
 to have and to hold all and singular the premises before mentioned
 unto the Said William Goodlett his heirs and assigns forever and
 I do hereby bind myself my heirs Executors Administrators to warrant
 and forever defend all and singular the Said premises before mentioned
 unto the Said William Goodlett his heirs and assigns against me myself
 my heirs and against every person Whomsoever claiming or to claim
 the same or any part thereof witness my hand and Seal this 17th
 May 1834 American Independence of the United States of America
