to us in hand paid by Henry B Prince of the district and State aforesaid  
We have granted bargained sold released conveyed and confirmed and  
by these presents do grant bargain sell and release convey and confirm unto  
Henry B Prince all our parts rights titles and claims to an undivided tract  
of five hundred acres of Land more or less lying and being in the State and  
District aforesaid on the Waters of South Syger River with by our Father to be  
sold when the youngest heir Beby W Barrett comes of age unless a friendly  
Divide could take place Together with all and Singular the rights members  
Heredetements and appurtenances to the undivided premises belonging or in  
any wise Incident or appertaining to have and to hold all and Singular  
our parts of the undivided premises afore mentioned unto the said Henry B  
Prince his heirs and assigns forever and We do hereby bind ourselves our heirs  
Executors & Administrators to Warrant and forever defend all and Singular  
our parts of the said premises unto the said Henry B Prince his heirs and assigns  
against ourselves and our heirs and against every person or persons Lawfully  
Claiming or to claim the same or any part thereof Witness our hands and  
Seals this twentieth of October A.D one thousand eight hundred and thirty  
four and in the fifty eighth year of the Independence of the U.S.A
