released and by these presents do grant bargain sell and release  
unto the said John Hopkins his heirs and assigns all that tract of  
land in said State and district last, the general muster ground  
on both sides of the ready fork of ready River containing five hun-  
dred acres be the same more or less beginning on a dead oak  
Major Berry's corner thence S. 2. E. to a stake 3x Earles corner thence  
N. 38. E. 88 to a stake also Earles corner thence N. 2. W. to a black oak  
on the fork Shoal road Mrs Harrison's corner thence on her line  
to a B. & 3x near the old field thence on her line till it intersects  
the Winn line at her fence thence along her line and fence across  
the Greenville road to rock corner thence thence in a direction to  
strike the continuation of Major Berry's line at a point on the  
North fork of the Creek thence to the Beginning to have and to  
hold the premises as above described to the said John Hopkins  
his heirs and assigns forever with all and singular the rights  
members hereditaments and appertaining belonging to the same  
or in any wise incident or appertaining and I do hereby bind  
myself my heirs Executors &c to warrant and forever defend the  
same against me and mine and against every other person or  
persons lawfully claiming the same or any part thereof in testimony  
of which I have hereunto set my hand and affixed my seal this
