 Red oak thence S 35. E. 4. 00 to a post oak thence N. 13. E. 25 to area oak thence
 N. 23 3/4. E. 7. 50 to area oak thence N. 8. W. 3. 17 to area oak thence N. 28. W. 45. 75
 across creek to a Rock thence Due North 4. 65 to area oak thence N. 26 1/2. E.
 21. 60 to a Red oak thence N. 35. W. 16. 90 to Chesnut at the head of a branch
 thence down said branch 21. 45 to a sapling at the North River thence
 down said River 66. 00 to a Rock thence due West 20 across the North
