or appertaining to have and to hold all and singular the premises
before mentioned unto the said Burn his heirs and assigns forever
and I do hereby bind myself my heirs Executors and administrators
to warrant and forever defend all and singular the said premises
unto the said Burn his heirs and assigns against myself and my
heirs and against Every person whomsoever Lawfully claiming or to
