Oak thence N 36° E 7.50 to a slate thence S 62° E 9.50 to a maple thence S 26°  
5.50 to a white Oak thence S 6 E 4 to a black gum on the branch thence  
Down said branch to a Oak corner thence S 8 E 36 to a slate on musk  
Creek thence up said to the beginning all and singular the rights  
members hereditaments and appurtenances to said premises belonging or  
in anywise incident or appertaining to have or to hold the said premises unto  
the said Dennis Westmoreland his heirs or assigns for ever and I do
