South Carolina I know all men by these presents that I Simon Lester Greenville District ³ of the State and District aforesaid for and in consideration of the sum of Thirty Dollars to me in hand paid by James Smith of the same State and District have given granted bargained sold released and conveyed and by these presents do give grant bargain sell release and convey unto him the said James Smith a certain tract or parcel of land situate lying and being in the State and District aforesaid on waters of Middle Tyger River and bounded as follows Viz Beginning on a Chestnut Stump running thence N 61 East 18 Chains to a Red oak 3x thence North 4 Chms to a Red oak thence South by W. 24 Chs 50 Links to a Black oak thence S. 46 E. 9 Chs 50 Links to the beginning containing fifteen acres to be the same more or less To have and to hold the above granted premises unto him the said James Smith his heirs and assigns forever Together with all and singular the Rights Members hereditaments and appurtenances thereunto belonging or in anywise incident or appertaining and I the said Simon Lester do hereby bind myself my heirs Executors Administrators and Assigns forever to warrant and defend the above granted premises unto him the said James Smith his heirs and assigns against myself my heirs and assigns and against any and every other person or persons wheresoever lawfully claiming the same or any part thereof In witness whereof I have hereunto set my hand and affixed my seal the thirteenth day of October One Thousand Eight hundred and Thirtynine Signed sealed and delivered in presence of *John C. Hoyt John Watson*

South Carolina I know all men by these presents that I William Pollard of the Greenville District ³ District & State aforesaid for and in consideration of the sum one Hundred dollars in hand paid me by George Croft of s^d District have granted bargained & sold and by these presents do grant bargain sell and release unto the s^d George Croft a certain tract or parcel of land originally granted to Robert Gilleland and laid out as follows beginning on a stone corner on s^d Croft line on the Road near the corner of his field on the waters of Ready Fork Creek of Reedy River and running North Westerly to a Black oak thence S.W. to a black O. thence N.W. to a maple on a small branch on Mayfield's line thence down s^d Branch to the Pine corner on s^d Croft line thence along said line ⁶⁶ to the beginning including Twenty acres more or less Together with all and singular the members Hereditaments and appurtenances to have and to
