South Carolina I Know all men by these presents That I of H Benedict of Greenville District ville District & in the State aforesaid in consideration of the sum of one hundred & twenty Dollars to me paid John Markley of the Town of Greenville in the state aforesaid have granted, bargained sold and released, and by these presents do grant bargain sell, and release unto the said John Markley All that Piece or parcel of land near the Town of Greenville & bounded as follows to wit Beginning at a stake Peter Caubles Corner & runs thence North 68 East 154 feet 10 inches to a stake thence North 15 West 336 ft to a stake on the lane 16 $\frac{1}{2}$  ft wide thence North 44 West 118 ft six inches to a stake corner of Markleys lot thence South 16 West 177 ft 8 inches to a stake Caubles & Markleys corner thence South 18 East 192 ft to the beginning; Being the same land conveyed to J H Benedict by Vandy M Lee by deed date 5 day of November Eighteen Hundred and thirty eight The quantity of Land agreeable to calculation being One acre One Rod & Eighteen Pds be the same more or less.
