to me paid by Joniah Wilgore, have granted bargained sold and
released and by these presents do grant bargain sell and release
unto the said Joniah Wilgore all that plantation or tract of Land
which I now live on situate in Greenville District on Horsepen and
Gilders Creek. Containing five hundred and Seventy two acres more
or less, beginning at a Maple 3/4, Joniah Wilgore's corner on Horse-
pen and down said Creek to Gilders Creek, then up Gilders Creek
to a Poplar on the Bank of the said Creek about 20 yards below
the Milldam, then on said Joniah Wilgore's line S 9. 71. 3. 25 to a
P. Oak bush 3/4, then N. 78. 7. 20 to a Persimmon 3/4 on Jones Spring
branch then N. 31. 7. 18. 75 to a Sp. O. 3/4 on Samuels 19. Hill's line
then with Hill's line S. 39 1/2 W to a stake then N. 38. 7. 7. 50 to a stake
White Oak 3/4 on the North side of Gilders Creek, then on W. M. Kable's
line to the cool Branch and up said branch to its head then S 25.
E. 41. 25 to a white Oak 3/4 on a small branch; then on Painter's Stony
line S. 71 E. 26. 00 to a P. O. 3/4, S 31. 50 to a stake 3/4 and stone S 34.
E. 20. to a P. O. 3/4 then N. 57. E. 34. 50 to Hickory 3/4, then on said
Wilgore's line N. 14 1/2 W 37. 00 to the beginning together with all
and singular the rights member tenements and appurtenances
to the said premises belonging or in any wise incident or apper-
