 covenant promise and agree to pay to and with the said Vardy M. G. Bee
 B. Dunham. Peter Boule. R. Garland. S. R. Whittow & William Blasingame
 their Executors administrators and assigns by these presents that if they or any
 of them have any money or monys to pay for me as my securities on the land
 above mentioned or shall incur in any way any liability and which I shall not be
 able to meet and release them and in case it shall and may be lawful to and for the
 said Vardy M. G. Bee. B. Dunham. Peter Boule. R. Garland. S. R. Whittow and William
 Blasingame their Executors administrators and assigns, attorneys or agents from
 time to time and at all times hereafter peaceably and quietly to enter into any or
 all mesnages lands or tenements of the said David Henning and to take into custody
 and possession & the same to hold & detain to their own use and behoof as their
 own proper goods and chattels from hence forth and forever or the same to sell
 & dispose of at will & pleasure, returning the overplus if any should happen to
 be after paying the said sum or sums of money which they may have to pay
 on the land or as securities to the said D. Henning for his acts and conduct
 as sheriff of Greenville District to the ^{said} D. Henning his heirs & executors
