

201 Greenville District I, David Henning of Greenville District in the state aforesaid do stand & greeting - Whereas I the said David Henning am justly indebted by notes and Books of Accounts to B. Dunham, Peter Coulter & Roger Lorland separately and individually to large amounts in the whole amounting to Five thousand dollars and whereas the said Benjamin Dunham, Peter Coulter and Roger Lorland together with Vardry M'bee have agreed to assist me in the payment of my other debts to the amount of Five thousand dollars more by endorsing for me and apuring my debts to that amount - Now know ye that I the said David Henning for the letter securing the payment of the said sum of Five Thousand dollars which I owe the said B. Dunham, Peter Coulter & Roger Lorland by notes and Books accounts and also for the letter securing the said B. Dunham, Peter Coulter, R. Lorland & Vardry M'bee in the payment of the sum of Five thousand dollars which they are to apurne for me of my debts or endorse for me so as to enable me to pay that amount of debts now due in addition to the five thousand dollars which I owe the said B. Dunham, Peter Coulter, R. Lorland together with lawful interest on the whole amount to be paid to the said B. Dunham, Peter Coulter & Roger Lorland and Vardry M'bee on the first day of January in the year of our Lord one thousand eight hundred & forty two. I the said David Henning have bargained and sold and by these presents do bargain and sell and in plain open market deliver unto the said B. Dunham, Peter Coulter, Vardry M'bee and Roger Lorland the following property (viz) negroes, Nelly, Kit and Mary all my stock in the San Yard of every description
