 & Wardry M^r Bee their Executors, administrators and assigns forever.
 Provided always nevertheless that if the said David Henning my heirs executors and
 administrators shall and do well truly pay or cause to be paid unto the said, Benjamin
 Dunham, Peter Couble, Roger Loveland, and Wardry M^r Bee their certain attorneys
 executors administrators or assigns the several amounts which I owe the said, B. Dunham,
 Peter Couble, & Roger Loveland, by notes & books accounts amounting in all to Five Thou-
 sand dollars and also the sum of Five thousand dollars which they are to endorse
 or assume for me towards the payment of my debts due other persons according to
 the true intent and meaning of the notes accounts, one of these presents together with law-
 full interest on the first day of January in the year of our Lord one thousand eight-
 hundred & forty two, then this deed of Bargain & Sale and all every clause article and
 thing therein contained shall cease determine and be utterly void and of none effect
 any thing herein contained to the contrary whereof in any wise notwithstanding
 And it is hereby declared by and between the parties and the said David Henning his
 executors administrators and assigns does covenant, promise & agree to and with
 the said, B. Dunham, Peter Couble, R. Loveland, & Wardry M^r Bee their heirs, executors
 administrators and assigns by these Presents that if default shall happen to be
 made of or in payment of the said sum of Five thousand dollars aforesaid to the said
 B. Dunham, Peter Couble, Roger Loveland, and Wardry M^r Bee are to assume pay
 or endorse for the said David Henning according to the true intent & meaning
 of these presents as above expressed - or if the said, B. Dunham, Peter Couble, R.
 Loveland, Wardry M^r Bee should have to pay any of the debts which they may
 assume of mine or which they may endorse for me before the expiration of
 the time above mentioned namely Eighteen hundred and forty two then and
 in such case it shall & may be lawful to and for the said B. Dunham, Peter Couble
 Roger Loveland & Wardry M^r Bee their Executors administrators attorneys or agents
 from time to time and at all times hereafter peaceably and quietly to enter into any or
 all the Mesuages lands or tenements of the said David Henning and to take the
 said negroes household and kitchen furniture and stock in the Saw Yard into their
 custody and possession and the same to hold and detain to their own use & behoof
 as their own proper goods & chattels from hence forth and forever or the same to sell and
 dispose of at will and pleasure returning the overplus if any should happen to be after
 paying the said sum of Five thousand dollars to the said B. Dunham, Peter Couble
 & R. Loveland and also the sum of Five thousand dollars which the said, B. Dunham
 Peter Couble, R. Loveland & W. M^r Bee are to assume for him towards the payment of his
 debts to the said David Henning his Executors administrators or assigns - In witness
