

& three quarters be the same more or less situated in the district of Greenv-
ille & State aforesaid lying on a branch the waters of Goshock creek Bounded
on the North west by said Wilson and the S.E. by the said Mayfield Beginning
at a White Oak Stump on the bank of a branch of Goshock thence S. 05 E. 34.35 to a
gum on the branch thence up the said branch S. 26 W. 4.15 to a dogwood thence
N 85 W. 00 to a forked pensinow on the East side of the Road to Mostellers Mills
thence N 32 W 18.45 to the Beginning Together with all & singular the
rights, manors, hereditaments & appurtenances therunto belonging
