 heirs and assigns forever and I do hereby bind myself my heirs, executors &  
 administrators to warrant and forever defend all and singular one  
 half of the said premises unto the said G. F. Westmoreland his heirs and  
 assigns against myself and my heirs and assigns and against any  
 other person or persons lawfully claiming or to claim the same or any part  
 thereof Except Cornelius Mangum or his heirs or assigns Witness my hand  
 I seal this the tenth day of November eighteen hundred & thirty four  
 signed sealed Delivered in the presence of us

Further the understanding of both of the parties is as follows if any  
 of the above tract of Land herein mentioned should be lawfully taken from  
 the said G. F. Westmoreland by the said William Ford obligate myself  
 by this instrument to refund back to G. F. Westmoreland at the rate  
 of one dollar per acre for one half of the amount taken or lost without  
 interest day and date above written
