The said tract of land above described to Bound on the Pendleton Road on the south end of the same the Road being one hundred feet wide and all the space between the beaten tract of the said Road and the corner and lines called for above on the said Road to be considered the public Road and used for no other purposes. the survey of the said tract of land having been recently made by John Watson Esqr. the Plat of the same is hereto annexed which will more fully show the shapes Mites and Boundaries of the said tract of Land where Reference is had to the same.
