I, William M. Goodlett Sheriff of Granville District and State aforesaid
and greeting. Whereas, by virtue of sundry writs of Fieri Facias
issued out of the Court of Common Pleas held for the District of

And whereas the said premises with their Appurtenances since the seizure
by me made by virtue of the said Writ of fieri facias before mentioned
have been exposed to sale at publice vendre and purchased by Elias Hill of
the District aforesaid for the sum of Forty four Dollars being the
highest sum that was bid therefor. Now know ye that I William
M. Goodlett Sheriff aforesaid by virtue of the said Writ of fieri facias
aforesaid to me directed and delivered by aforesaid and by virtue of
the Statute in such case made provided and for and in consideration
of the said sum of Forty four Dollars to me in hand paid or secured
to be paid by the said Elias Hill the receipt whereof I do
hereby acknowledge have granted bargained sold and by these presents
do grant bargain and sell unto the said Elias Hill his heirs and
assigns forever the said tract piece and parcel of land with its
Appurtenances and all the estate right title and interest which
the said Peter R. Bopp of right had of in and to the same
I have and to hold the said piece parcel and tract of land
with its Appurtenances unto the said Elias Hill his heirs
and assigns forever as fully and absolutely as the said Sheriff
might could or ought to grant bargain and sell the same
by virtue of the Statute aforesaid and the said Writ of fieri
