 $N.57^{\circ} E 18\frac{1}{2}$ to a Poplar $\frac{3}{4}$. thence $S.65^{\circ} W. 28\frac{1}{2}$ chains to a Stake $\frac{3}{4}$. thence $N.9^{\circ} E 23$
chains to a Rock $\frac{3}{4}$. thence $N.83^{\circ} E 2.00$ chains to the Beginning
Together with all and singular the rights members and appurtenances there-
unto belonging or in anywise incident or appertaining. To have and to hold
