acres two rods, and Twenty nine poles lying near the Village of Greenville
On the North side of the Buncimbe Road being the same that the said
Peter G Gerard Conveyed to me by Deed of even date herewith.
Together with all and singular the Rights, Members, Hereditaments,
and Appurtenances to the said Premises belonging, or in any wise incident
or appertaining To Have and to Hold all and singular the said Premises
unto the said Peter G Gerard his heirs and assigns forever. And
I the said George Patton do hereby bind myself & my heirs, Executors
Administrators, to warrant and forever defend all and singular the
said Premises, unto the said Peter G Gerard his heirs and assigns,
from and against my heirs, Executors, Administrators assigns & all other
persons lawfully claiming or to claim the same or any part thereof
Provided, always, nevertheless, and it is the true intent and meaning
of the parties to these presents, that if of the said George Patton do and
shall well and truly pay or cause to be paid unto the said Peter G Gerard
the said Debt or sum of Money aforesaid with the Interest thereon if any
shall be due according to the true intent and meaning of the said Notes,
then this Deed of Bargain and Sale shall cease, determine, and be
utterly null and void otherwise to remain in full force and virtue
And it is agreed by and between the said parties that the said George
Patton is to hold and enjoy the said Premises until default of payment
