I now know all morally these presents that I
Benjamin Hager of the District of Dickens and State aforesaid you and
in consideration of the property conveyed to me in Trust by John Wilson
Barton above mentioned and in consideration of the further sum of Three
Hundred Dollars to me in hand paid I have covenanted and agreed and
do hereby covenant to agree with the said Wilson Barton this day and agrees
as follows I am to receive the lands and negroes and other property mentioned
in said Bartons Deed of Trust to me and hold the same according to
the Terms of the said Deed of Trust I am to support and protect this
said wife Rebecca P. Barton of the said property and save the said Wilson
Barton from all liability whatsoever for or on account of the support of this said
wife during her life time I am to protect him and defend his title to
the following negroes viz Spence, and Sally his wife and his four chil-
dren Martha, Lucy, Lizzie and William and then increase against all
claims on the part of this wife or any one else In case the said Wilson Ba-
tron should die before this said wife Rebecca then and in that case spe-
cifically I warrant to the said Barton and his heirs the above named ne-
groes and then increase which would under the marriage settlement revert
to the said Rebecca Barton I am likewise to protect the said Wilson Barton
against all claims which this said wife Rebecca Barton may have against
his estate in any way whatsoever for losses or disbursements shown on the same
I am also to protect him the said Wilson Barton against his wife or any
one claiming under her on account of any property mentioned in their mar-
riage settlement or any interest which she may have in said settle-
ment I also agree to save the said Wilson Barton harmless on account of the
six hundred and Sixty three dollars received of Davis Hodges from the Wills
which were to have been erected on the home place by John Hodges
Hodges also against all liabilities which he may have been under in
exchanging him for Spence and against all claims his wife may have
for him also I guaranteed to him the Three Hundred Dollars which he has
occurred for the good Track of land and secured the rest on the said
land which he has also received

I covenant and agree further with the said John
Wilson Barton that the delivery of the property enumerated in his Deed of
Trust to me shall be in full of all demands whatsoever which this
affair now has or may hereafter have against him or his estate
on account of any property which she ever had or any claim which she
may have in this estate or property or liability he may be under to her
any way And I further covenant that the said property shall be
safe against all demands that any other person or persons may
