that A B Brook Executor of P Hawkins

Hawkins died in the District of Greenville in the State aforesaid for and  
in Consideration of the sum of Fifteen hundred and fifty dollars  
now paid by Perry C Duncan of Greenville District in the State aforesaid then  
granted, bargained, sold and released and by these presents do grant the  
said sum and release unto the said Perry C Duncan all that Tract or piece of  
Land of Fair Situate, lying and being in the District aforesaid one hundred and  
Fifty acres branch of Reedy River on both sides of that road leading from old  
Greenville to Unionville containing three thousand and twenty one acres  
more or less it being a part of the original Grants namely one granted to the Am  
Jacobs Langston 3<sup>d</sup> April 1786 another part of a Grant made to James road  
McClay and the other part supposed to John Montgomery and Charles Smith  
marked he as follows namely Beginning at Hickory st Thence S 71 E 10  
W 21 E 6 to a Hickory st Thence S 78 W 45 E to a pine st Thence W 68 W 66 E  
a Stake of a Post Oak near to a Hickory st Thence S 29 W 17 E to a Stake st  
Thence S 60 E 61 to a post oak sapling st near the Spring Thence S 31 W to a Post Oak  
st Thence S 49 E 17.50 to a Stake st Thence N 29 E 26 to a post oak st Thence  
W 59 W 17.50 to a post oak stump pointed Thence S 729 E 25 to a Stake by a large  
Cherry st by Stephen Phillips Still House Thence W 25 to a Stake of a post oak  
on the Unionville road Thence N 10 58 to the beginning corner

Together with all and singular the Rights Members & Chattels  
and Appurtenances to the said Premises belonging or in anywise incident or  
appertaining to have and to hold all and singular the Premises before  
mentioned unto the said Perry C Duncan and his heirs and assigns for  
ever And I do hereby bind myself as Executor of P H. Hawkins Executor of  
Administrators to warrant and forever defend all and singular the  
said Premises unto the said Perry C Duncan & his Heirs and assigns  
against me and P Hawkins heirs and against every person whomsoever lawfully  
claiming or to claim the same or any part thereof
