D Hawkins all that tract or parcel of land situate lying and being in the District and State aforesaid containing one hundred and twenty five acres less the same more or less lying on both sides waters of Hucky River Beginning at a rock corner formerly a Post oak near the Burnside Road and thence N^E 40° W 58.13 chains to a Hickory 37.5x Thence N^E 40° W 21.50 chains to a Hickory 37.5x Thence S 18° E 103.50 chains to a Stake Thence S 66° E 13.20 to a post oak Thence S 44° E 25.16 to small pine Thence S 44° E 14.75 to a popular Thence S 84° E 5.25 to the beginning corner

Iog. This with all and singular the rights, members, franchises and appurtenances to the said premises belonging or in any wise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the said J. D Hawkins his heirs and assigns forever and I do hereby bind myself my Heirs executors and administrators to warrant and forever defend all the right title and interest which was conveyed to me by deed of A B Brook executrix of Pinckney Hawkins deceased bearing date the fifth day of November one thousand eight hundred and forty nine in conveying to me the tract of Land known as the Rock place of which the tract had been conveyed separately as will more fully appear by reference to a plat made by Willis D Sheldahl bearing date the 11th day of September 1849 as J. D Hawkins and myself purchased jointly under the seal of A B Brook executrix. It is not intended in this deed to convey any other or any more title or warranty than I acquired under that title. But all that and only that I do hereby convey to the said J. D Hawkins his Heirs executors and assigns against myself my Heirs executors and assigns and against every person else claiming under me.
