that certain tract or plantation of land situate in Greenville District in the
state aforesaid on a branch of Rocky Creek Branch also on Branches
of Sulphur Creek Branch waters of Saluda River containing Two hundred
and thirty three acres and one quarter and tenth such shape form and
marks as are represented in a plat thereof made by Miller & Throckmorton
Surveyor on the twenty fifth day of March anno Domini One
Thousand eight hundred and fifty four and annexed to the said land and
intended to form part and parcel of the same

Together with all and singular the rights, members, appendments
and appurtenances to the said premises belonging or in any wise incident or appertaining
to have and to hold all and singular the said premises unto the said Benjamin
H Wilson his heirs and assigns forever that I do hereby bind myself my heirs
executors and administrators to warrant and forever defend all and singular
the said premises unto the said Benjamin H Wilson his heirs and assigns against
one and my heirs and against all persons whomsoever lawfully claiming
or to claim the same or any part thereof.
