This Indenture Made the seventh day of May in the year of our Lord one thousand eight hundred and fifty five

between me, Robert Murray of the one part and Samuel A. Somers Esquire Commissioner of the Honourable Court of Equity for Greenville District of Greenville County in the State of South Carolina of the other part the said Michael McElroy and others on or about the 29th day of March in the year of our Lord one thousand eight hundred and fifty five exhibited their Bill of Complaint in the Court of Equity at Greenville County Courthouse in the said State against Robert Murray and wife and others praying the partition of the Real Estate No. 1002 the cause being an issue before the Honourable Court came on to be heard at Chambers 3rd day of April in the year of our Lord one thousand eight hundred and fifty five when the said Court after full hearing thereof and mature deliberation in the premises did order adjudged and decree that the Real Estate described in said Bill of complaint should be sold at Public Auction by the Commissioners of the said Court on the terms and for the purposes mentioned in their Recital Order as by reference thereto in the Registry of the said Court will appear and the said Samuel A. Somers as Commissioner of the said Court after having duly advertised the said Real Estate for sale by Public Auction on the seventh (7th) of May in the year of our Lord one thousand eight hundred and fifty five and then, openly and publicly and according to the custom of Auctions, sell and dispose of the said Real Estate above described unto the said Robert Murray for four thousand dollars the being at that price the highest bidder for the same.

For therefore this Indenture witnesseth That the said Samuel A. Somers as Commissioner of the said Court under and by virtue of the said Decree and in consideration of the sum of Four Thousand Dollars paid him by the said Robert Murray the receipt whereof is hereby acknowledged and granted, Bargained Sold and Released and by these presents doth Grant Bargain, Sell and release unto the said Robert Murray his Heirs and assigns all that tract, parcel and lot of Land wherein are described as follows Beginning at a Post Oak corner on the west side of the Bumcombe road running thence N 44 E 16 ch to a small Red corner thence S 84 E 6 ch to a N 80 E corner, thence S 44 E 3 ch N 87 E to a W 100 corner, then commencing again at the beginning corner and running thence S 35 E 8 chains and 30 links to a stake being the corner of George W. Lyle's land thence N 44 E 24 ch and 45 l to the beginning aforesaid W 80 corner bound on the North by lands of Edward Croft and Ward Long on the East by lands of Major Lynch on the South by lot of Robert Murray and the Bumcombe Road on the West by lands of Edward Croft the above lands is exclusive of the lot conveyed by Dr C. B.
