I do declare always hereafter that it is the true intent and meaning of these Presents that if I the said Nicholas P Burgos do and shall well and truly pay or cause to be paid unto the said James or his successors in office or their assigns, The sum of debt or sum of money aforesaid with the interest thereon if any shall be due according to the true intent and meaning of the said Bond and Condition therein written then this Deed of bargain and sale shall cease determine and be utterly null and void otherwise it shall remain in full force and virtue And it is agreed by and between the said parties that I the said Nicholas P Burgos am to have and enjoy the said premises until default of payment shall be made
